01. The rates should be quoted F.O.R. IISS, NabiBagh, Bhopal basis along with indicating separately brand name its price, packing forwarding, freight, tax percentage and insurance etc. in clear terms.
02. Quantity of discount, if any, should be indicated clearly.
03. This institute is registered with the Department of Scientific & Industrial Research (DSIR), Govt. of India for purposes of availing custom duty exemption in terms of Government Notification No 51/96-Customs dated 23 July 1996 and central excise duty exemption in terms of Government Notification No. 10/97-Central Excise dated 1 March 1997.
04. Rates of Tax; As per notification No. 45/2017-Central Tax(Rate) dated 14.11.2017 issued by the Min. of Finance, Scientific and Technical instruments, apparatus, equipment (including computers) are exempted from the Central tax (in excess of 2.5%) leviable there on under section 9 of the Central Goods and Service Tax Act,2017 supplied to the Departments & Laboratories of the Central Government and State Governments, other than a hospital. Since, this Institute is a Scientific Research Institution under Indian Council of Agricultural Research, Min. of Agriculture Govt. of India, and also registered by Min. of Science and Technology, DSIR, New Delhi vide their Registration Certificate No. TU/V/RG-CDE (504)/2016 dated 09.01.2017 **the GST has to be charged accordingly. A GST exemption certificate shall be issued along with supply order.**
05. Unless otherwise mentioned in the quotation, it will be presumed that the quoted rates are inclusive of all taxes/levies and free delivery/installation at our Institute.
06. The rates quoted should be valid for 90 days from the date of opening of quotation.
07. Quotation should be submitted along with printed literature/ catalogue of the quoted make/ model and authorization certificate of the manufacturer. Quotation without mention of make/Brand shall not be considered.
08. There should be no cutting/ overwriting. The cutting if any should be duly attested.
09. Unattested/amended/overwritten figures will not be considered.
10. In all matters of disputes, the decision of the Director of this Institute shall be final and binding.
11. Minimum period of delivery of the stores/materials should clearly be specified in the quotation.
12. TDS/ VAT will be deducted from the bill as per applicable tax rules of GOI/M.P. Govt.
