Subject : Order of the Appellant Authority under Right to Information Act - 2005.

Appellant : Dr. Ravinder Kumar Agarwal, A-1/30, Sector-18, Rohini, Delhi-110089.

Reference : Appeal dated 8.8.2013 received on 20.8.2013.

I have gone through the appeal dated 8.8.2013 made by the Appellant, Dr. Ravinder Kumar Agarwal, A-1/30, Sector-18, Rohini, Delhi-110089 received on 20.8.2013 against the information/reply furnished by the CPIO (Per.I) vide letter dated 29.7.2013 against the RTI application of the Appellant dated 10.7.2013. The Appellant had asked for the following information :-

1. List of the scientists, with their details such as name, designation, affiliation, date of posting, etc. who have completed 15 years of service or more at one place of posting in a stretch without transfer as on 30.6.2013.
2. List of the scientists, with their details such as name, designation, affiliation, date of posting, etc. who have completed 45 years of age as well as 15 years of service or more without serving in backward or comparatively less developed areas accordance with the provision of Rule 20(2) of the Agricultural Research Service Rules and other record relevant in the matter (Council's letter No. 8-16/76-Per.IV dated 17.11.1980 and Council's letter No. 8-16/76-Per.IV dated 18.7.1981) as on 30.6.2013.

The CPIO in his reply informed the Appellant that "no such list is available in the Personnel Section. However, the applicant can inspect the file on any mutually convenient date with the undersigned".

The Appellant in his appeal has stated that the CPIO did not put in any effort to collect and provide information and, therefore, his reply is evasive. He has, therefore, requested to direct the CPIO to furnish the information sought by him as per his RTI application dated 10.7.2013. He has also requested to inform him the date and time as well as venue of the hearing of the matter.


In this connection, attention is invited to the DoP&T O.M. dated 27.2.2008 which refers as under :-

"Only such information is required to be supplied under the Act which already exists and is held by the Public Authority or held under the control of the Public Authority. The CPIO is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions."

The Appellant is informed that the scientific cadre of ICAR constitutes more than 6000 scientists and they are working in 105 Research Establishments/Institutes of ICAR spread all over the country. For furnishing the information as required by him, the details have to be collected specifically from these 105 Institutes which is a cumbersome and time consuming exercise. I, therefore, fully endorse the views of CPIO (Per.I Section). However, the CPIO (Per.I) has been directed to collect the information by sending an e-mail to all the Institutes and information will be furnished to you as and when it is received and compiled by CPIO (Per.I Section).

As regards your request for intimating the date, time and venue of the hearing, the Appellant is informed that there is no provision for conducting a hearing in the matter by the First Appellate Authority. However, there is a provision to allow for inspection of the documents, if any, required by the Appellant and if he desires, he may come to the Krishi Bhavan at Room No. 220, ICAR on a mutually convenient date in October, 2013 under prior intimation to the undersigned so that necessary arrangement for inspection of the documents will be made accordingly.

This disposes of your appeal dated 8.8.2013.


